

**RESOLUTION NO. 08-16**

**RESOLUTION OF THE BOARD OF DIRECTORS OF  
RUNNING SPRINGS WATER DISTRICT ESTABLISHING  
APPROPRIATIONS LIMIT FOR FISCAL YEAR 2016-2017**

WHEREAS, Article XIII B of the California Constitution places an annual limitation upon appropriations from proceeds of taxes by each local government of the State of California; and

WHEREAS, Section 7910 of the California Government Code implements Article XIII B of the California Constitution by requiring each local jurisdiction to establish, by resolution, its appropriations limit for each fiscal year, beginning in 1980-81, and to make the documentation used in determining the appropriations limit available to the public fifteen days prior to adoption of the resolution establishing the appropriations limit; and

WHEREAS, in accordance with Senate Constitutional Amendment No. 1 approved by the voters of the State effective June 6, 1990, beginning with fiscal year 1990-91 and for each fiscal year thereafter, the District's Board of Directors is required to select either the percentage change in California per capita personal income or the percentage change in the local assessment roll due to the addition of local non-residential construction, and either the population change within the District or the population change within San Bernardino County, as the two factors to be applied in calculating the appropriations limit for each fiscal year; and

WHEREAS, this Board wishes to select, as factors in determining the District's appropriations limits for fiscal year 2016-2017, the percentage change in California per capita personal income and also the population change within the unincorporated area of San Bernardino County; and

WHEREAS, this District has documented its calculations of the District's appropriations limit for fiscal year 2016-2017, and said calculations have been posted on the District's main office front window and made available to the public at least fifteen days prior to the adoption of this resolution;

NOW, THEREFORE, BE IT RESOLVED by the Board of Directors of the Running Springs Water District as follows:

1. For fiscal year 2016-2017, the factors selected for calculating the appropriations limit are (a) the percentage change in California per capita personal income, and (b) the population change within the unincorporated area of the County of San Bernardino.

2. The appropriations limit applicable to this District pursuant to Article XIII B of the California Constitution for fiscal year 2016-2017 is hereby established and determined to be the sum of \$4,676,518.

3. A copy of the documentation used in the determination of the fiscal year 2016-2017 appropriations limit shall be affixed hereto and shall be available for public inspection.

4. Pursuant to Section 7910 of the California Government Code, any judicial action or proceeding to attack, review, set aside, void, or annul the establishment of the appropriations limits as set forth herein must be commenced within forty-five days of the adoption of this resolution.

**2015-2016 Appropriations Limit** **\$4,408,067**

2016-2017 adjustment:

Change in California Per Capita Income = 5.37 percent  
Change in Population, Unincorporated San Bernardino County = 0.68 percent

$$\frac{5.37 + 100}{100} = 1.0537$$

$$\frac{0.68 + 100}{100} = 1.0068$$

$$1.0537 \times 1.0068 = 1.0609$$

$$\$4,408,067 \times 1.0609 = \$4,676,518$$

**2016-2017 Appropriations Limit** **\$4,676,518**
